### **Vice President of UIBE, Liu Ya met with Counselor Bakbergenov of Kazakhstan Embassy in China**

On November 4, Vice President of UIBE, Liu Ya met with Counselor Bakbergenov of Kazakhstan Embassy in China; Mr. Nurlan Dutbayev, Chief Representative of Kazakhstan National Welfare Fund Joint-Stock Company in China; Ms. Ronnados Mubekev, Deputy Representative of Kazakhstan Development Bank Corporation in China. The attendees at the meeting also include Ms. Liu Huili, Director of the 3rd Department of Training of Education and Training Bureau at China Development Bank; Mr. Xia Haiquan, Director of Department of International Affairs at UIBE; Mr. Yang Hongyi, Deputy Director of Personnel Department at UIBE; Zou Yasheng, Associate Dean of School of Banking and Finance at UIBE; Mr. Wu Weixing, Associate Dean of School of Banking and Finance at UIBE.



The theme of this meeting was to discuss the details of the ceremony to be held by UIBE on Nov. 12 for the invitation of Mr. Karimubertov, Chairman of the Council of Kazakhstan National Welfare Fund Joint-Stock Company, as the Honorary Professor of UIBE, and the ensuing Keynote Report Meeting. The two parties discussed when and where the ceremony and report meeting is to be held and in which form, and fixed the details such as the agenda, attendee and the decoration of meeting hall.

China and Kazakhstan are strategic cooperative partners, said Vice President Liu, and UIBE is disposed to work as active impulse to strengthen the friendship between the two countries. Liu said in his address that UIBE is an internationalization featured university and the ceremony to which UIBE attaches much importance is hoped to be an opportunity for further cooperation between UIBE and Kazakhstan Development Bank Corporation. He gained his Bachelor Degree of Mathematics in Moscow State University and his Master Degree in Kazakhstan State University of Management. In 1999, he was awarded PhD of Economics by Georgetown University (America). He worked as the Strategic Planning Commissioner of Kazakhstan from 1999 to 2001; First Vice Minister of Ministry of Finance, from 2001 to 2002; Minister of Economy and Planning & Budget, from 2002 to 2006; President of the Council of Pending Development Fund, from 2006 to 2008. He assumed as the director of presidential office in 2008. He has been elected as the Chairman of the Council and Board Member of Kazakhstan National Welfare Fund Joint-Stock Company since October 2008.
